**FORMATS: ELECTRONIC:** Submit ads via e-mail, web link or CD as Macintosh-compatible tiff files, eps files, pdf files or QuarkXPress files. Include all images. For 4-color ads, convert all colors to CMYK, but make sure that black type is truly black and not RGB color or a composite of four colors. For black and white ads, convert the file to grayscale or black and white. If possible, check this using Adobe Acrobat's Output Preview. Remember to embed fonts in PDF files. Files saved in earlier versions than the latest upgrade are preferred. **Please contact us if you have any questions.**

**PAPER:** Ads submitted on paper will be scanned, which affects quality. Ads with color images, gray areas (screens), or photos (halftones) can be scanned, but please submit sharp, high-resolution images on white paper or original, sharp photos. Faxes are not accepted. Please contact us if you have any questions.

**DO NOT EMAIL WORD, Excel, Publisher or other formats. They are NOT accepted unless printed on paper and mailed for scanning (see above). Low-resolution GIF files via e-mail are not accepted.**

**EXTRA FEES:** \$25 per ad charged for ad design, typesetting, or scanning ads submitted on paper.

**PROOFS:** Available only if copy received by July 6. Proofs are emailed as PDF files. If you need a mailed copy, Enclose SASE.
